2023-Jan Minute 26	PASSED: "Statement of Board Member Responsibility, Authority, and Expectations" will be developed. Ad-hoc committee formed to create the document.
2023-July Minute 19	PASSED: Dues & Life Membership Changes
2023-July Minute 20	PASSED: QST Print becomes up-charge. CEO empowered to offer refunds for unexpired term memberships affected by the new policy.
2023-July Minute 32	PASSED: Bylaw 31 Motion reinstated.
2023-July Minute 33	PASSED: Establish a formal procedure for restricting access to confidential ARRL information during investigations into unauthorized disclosures.
2023-July Minute 38	PASSED: Roll-call votes -- The revised policy allows a roll call vote to proceed if requested by a Director, seconded, and supported by at least five Directors.
2023-July Minute 42	FAILED: Moderation of ARRL-managed online discussion groups; requirement to precede action with citing a violation of the group's printed rules.
2023-July Minute 43	FAILED: Executive Committee review and approve all QST editorials prior to publication.
2023-July Minute 44	FAILED: Executive & HR legal expenses over \$2,500 be pre-approved by the Executive Committee.
2024-Jan Minute 44	FAILED: Evenly distribute voting power across ARRL Divisions.
2024-Jan Minute 46	FAILED: All meetings with Director quorums discussing ARRL business must be announced and accessible to all Board Officers, Directors, and Vice Directors.
2024-Jan Minute 49	FAILED: ARRL term members joining before September 1, 2023 to continue receiving printed QST or On the Air until their membership expires.
2024-July Minute 24	PASSED: Update roll-call policy. Introduce electronic voting. Place boundaries around ability to request roll-call voting.
2025-Jan Minute 28	PASSED: Revision of ARRL Bylaw 18 (clarity, fairness, and governance in Director and Vice Director elections. Declaring standards for campaigning)
2025-July Minute 13	PASSED: Update By-law 46 & Ethics Oversight. New "Board Member Statement on Authority, Responsibility, and Expectations", Conflict of Interest, 3rd party ethics investigation protocol.
2025-July Minute 14	PASSED: Appointing neutral independent 3rd party to review E&E decisions under Bylaws 42 and 46.
